1. Executive Summary:

Major outcomes, results and impact of the Chair, including on national policies, in relation to its objectives as stated in Article 2 of the Chair Agreement (between the Institution and UNESCO) (Not exceeding 300 words)

The current UNESCO Chair in Tourism and Sustainable Economic Development of the University of Las Palmas de Gran Canaria (ULPGC), continues the work of the former UNESCO Chair in Tourism Planning and Sustainable Development, in operation since the creation of the Programme in May 1991. During this reported period, it was reinforced the commitment and effort of the university community, civil society organisations and the people involved, accordance with the values of UNESCO, to link global communities in the fields of education, science, culture and communication, with the sustainable development of tourism, which has a direct impact on the social and economic well-being of populations.

As will be explained below, this Chair has had special relevance for Spain and its area of influence, as tourism has had to rethink itself in this period, due to the difficult circumstances it has undergone due to the COVID-19 pandemic.

The University of Las Palmas de Gran Canaria has made great efforts to promote, analyse, cooperate and develop training activities that guarantee the sustainable development of tourism and decision-making, including the economic aspects involved, especially for territories that are heavily dependent on this activity. With this Chair, the ULPGC aims to transfer and put into practice the knowledge produced, cooperating with local communities in developing countries, to address an integral eco-endo-development of tourism activity, with a direct impact on the welfare of the target populations, strengthening their capacities and enhancing their culture and concern for the environment.

During this period, more than 24 projects and multiple training, dissemination and cooperation activities have been developed, as well as 140 scientific publications, which are described in the new updated website of the Chair: https://catedraunescoturismo.ulpgc.es/en/.

All the activity of the Chair has been aimed at meeting the Sustainable Development Goals of the 2030 Agenda, and all within the framework of the UNITWIN Program.

In 2023, it is expected to be able to reach agreements with multiple organisations with which the Chair has been working, in order to continue implementing common initiatives in the field of economic and sustainable development of tourism, through ongoing projects. It is also expected to contribute, through research, to the knowledge necessary for decision-making at all levels: business, administrative, governmental and international.

The recent nomination to form part of the Global Sustainable Tourism Observatories (INSTO) of the World Tourism Organisation will produce the necessary synergies to give greater visibility to the Chair and consolidate its role in the generation of useful and updated information for society.

The Chair has been the main beneficiary of the CLIMAR project "Strengthening of research, innovation and knowledge transfer on climate change and tourism in higher education Institutions in Latin America", financed by the Erasmus+ program of the European Union for the period 2023-2025. This project has been the only one granted by the European Union under the Green Deal modality.

In addition, in 2023-24 the Chair hopes to consolidate a Sustainable Development and Regenerative Tourism Network attached to the UNITWIN Networks program, for which it has obtained multiple supports in this present period, in addition to having the CLIMAR project.

It is expected to continue with the regulated training activities (bachelor's, master's and doctoral degrees), as well as those activities of the Chair and ULPGC aimed at the sustainable development of tourism, in order to maintain the fourth position as a research centre in scientific productivity in tourism in Europe; second worldwide, shared with other institutions, in scientific productivity in marketing and destination management; fourth worldwide in scientific productivity in research on image and brand; and first in Latin America in scientific productivity in hospitality.

1) Human Resources during the reporting period

The UNESCO Chair in Tourism and Sustainable Economic Development from ULPGC involves 120 academics from different disciplines, as well as a large number of prestigious researchers and collaborators from the world's leading centres of reference in sustainable tourism. Through the ULPGC, more than 50 agreements have been signed with all kinds of organisations for the development of specific activities, serving as a think-tank and bridge between the academic world, civil society, local communities and policy makers.

The University of Las Palmas de Gran Canaria is a new Spanish public university with a great international projection. Forty percent of its enrolment are foreign students, mainly from Latin America and Europe, which is a fundamental asset in relation to the objectives pursued by the Chair, highlighting the use of new technologies and research related to tourism as the main driver of the Canarian and Spanish economy. It has international mobility programmes with a close involvement with society and high scientific productivity.

The ULPGC Research Professors and Collaborators of the UNESCO Chair in Tourism and Sustainable Economic Development belong to 5 research groups covering disciplines such as: Economics, Environment, Sustainability and Tourism, Transport Statistics, Spatial Planning, Business Management, Urban Design, Entrepreneurship and Innovation.
